

**22.19 HEATHCOTE TOWNSHIP RESIDENTIAL CHARACTER POLICY**

This policy applies to development, (including subdivision) and works in the Residential 1 and Low Density Residential Zones in Heathcote, within the area shown on Map 1 forming part of this Clause.

**22.19-1 Policy basis**

Heathcote township contains four precincts that display differing qualities. The core of the township contains its links with the original settlement, and therefore provides an important historical context to the character of the town. The other areas retain a spaciousness that reflects the country setting and varying qualities of vegetation. Retaining and enhancing a cohesiveness to the township is an important focus of the character guidelines.

This policy assists in achieving the objectives of the State Planning Policy Framework, particularly in relation to responding to neighbourhood character and urban design principles. The policy implements the objectives and strategies contained in Clause 21.05 by ensuring that development enhances the character of urban areas, and achieve high standards of urban design and amenity.

The policy implements the findings of the *City of Greater Bendigo Residential Character Study 2001*, that identifies the key existing characteristics and desired future character of the residential areas of Heathcote. Development in residential areas needs to respond to the particular built form and natural environment elements that achieve the desired future neighbourhood character of the area in which it is located. These elements include building form, scale, siting, materials, front fencing and vegetation density. The *Residential Character Study* defines character precincts based on the delineation of areas of similar character elements (as shown on Map 1 forming part of this Clause).

**22.19-2 Objectives**

- To ensure that development is responsive to the desired future character of the area in which it is located.
- To retain and enhance the identified elements that contribute to the character of the area.
- To implement the recommendations of the *City of Greater Bendigo Residential Character Study 2001*.

**22.19-3 Heathcote Township Policy**

In the Heathcote Character Precincts it is policy that the following Township Vision, Character Descriptions, Statement of Desired Future Character, Objectives and Design Responses are taken into account when considering any application to develop or subdivide land. Proposals that meet the Design Responses are also considered to meet the related Objectives.

**Heathcote Township Vision**

The identity of Heathcote as a country township surrounded by rural bushland, will be strengthened and maintained and its diversity will be unified by:

- Encouraging the retention of buildings that reflect the early settlement of the town
- Encouraging the use of appropriate building materials.
- Ensuring the siting of buildings to reflect spacing patterns.
- Ensuring building form and scale reflects predominant patterns.

- Encouraging the use of appropriate vegetation in public and private planting schemes.
- Encouraging open front boundary treatments.

**Heathcote Township Precinct 1 (HC1)**

***Character Description***

This Precinct is distinctive as it incorporates the core of the township including the older style dwellings that reflect the history of settlement of the township. The area has an informal and spacious feel due to the frequent lack of formal kerbing and footpath, the open style front fencing and the variety of building materials. The use of weatherboard also adds a lightness to the streetscapes, which counteracts the generally smaller than average setbacks.

***Statement of Desired Future Character***

The rural township character and openness of the streetscapes will be retained and enhanced.

***Objectives and design responses***

The Desired Future Character is to be achieved by the following Objectives and Design Responses:

**Heathcote Township Precinct 2 (HC2)*****Character Description***

The character of the Precinct is created by the mixture of low level building styles within spacious garden settings. The mixture of building materials provides an informality and lightness to the streetscape that is aided by the lack of formal kerbing and footpaths, the low pitched roof styles and the predominantly low, open style front fencing.

***Statement of Desired Future Character***

The informal rural township feel and spacious garden settings of the dwellings will be maintained and enhanced.

***Objectives and design responses***

The Desired Future Character is to be achieved by the following Objectives and Design Responses:

**Heathcote Township Precinct 3 (HC3)*****Character Description***

This Precinct has a spacious semi-rural open bushland character created by the rural style houses in a spacious, low-density residential setting with generally low level native gardens, set amongst remnant native trees. Dwellings are average in size, are usually low scale and horizontal in form, and are usually offset large distances from all boundaries. The semi-rural appearance is assisted by the frequent lack of front fencing or use of farm style fencing, the use of a mixture of building materials, the sometimes informal placing of buildings on the site and the unmade street treatments and informal remnant street trees.

***Statement of Desired Future Character***

The semi-rural open bushland environment and spaciousness of the area will be retained and enhanced.

***Objectives and design responses***

The Desired Future Character is to be achieved by the following Objectives and Design Responses:

**Heathcote Township Precinct 4 (HC4)*****Character Description***

This Precinct includes isolated pockets of newer styles of development, set within a semi-rural landscape. The areas are distinctive due to the predominantly brick materials, the formal street treatments with kerbing, the standard setbacks and the establishing gardens. Cohesiveness of these areas with the remainder of the township is assisted by the remnant street tree vegetation and the openness of the streetscapes created by the lack of front fencing.

***Statement of Desired Future Character***

The visual cohesiveness of the areas within this Precinct with the remainder of the township will be enhanced.

***Objectives and design responses***

The Desired Future Character is to be achieved by the following Objectives and Design Responses:
